

POLICE REPORT for September 2016

This **ROBBERY-BUSINESS PROPERTY** took place at **04:10:00** on **SUNDAY 28-AUG-2016** at **ESSO SERVICE STATION, CROWN LA, WARESLEY, KIDDERMINSTER, WORCESTERSHIRE**

Unknown persons have entered the Esso Petrol Station Spar store, Crown Lane, Waresley, threatened the lone member of staff with a crowbar to stand still or they would hit him. They have then proceeded to steal an unknown amount of Amber Leaf tobacco packets, believed to be several packets, and placed them into a sack, before emptying one till of believed to be £60 in notes, and then a second till of believed to be £200 in notes. They have then left the store and believed to have turned left out the door and made off

This **INTERFERENCE WITH MOTOR VEHICLE** took place between **10:00:00** on **THURSDAY 25-AUG-2016** and **22:00:00** on **MONDAY 29-AUG-2016** at **QUARRY BANK, HARTLEBURY, STOURPORT ON SEVERN, WORCESTERSHIRE**

Offence location was a road in a residential area. Between times and dates stated PUK have used unknown object to cause damage to a blue Landrover Defender which was parked on the roadside outside the IP's home address. PUK have attempted to break off the steering wheel lock but were unsuccessful. PUK have made off direction and method not known

This **THEFT** took place between **02:18:00** on **THURSDAY 01-SEP-2016** and **02:18:00** on **THURSDAY 01-SEP-2016** at **TITTON, STOURPORT ON SEVERN, WORCESTERSHIRE**

At the stated times person/s unknown have approached the farmyard at location from an unknown direction. Entrance to the farmyard is secured by an electric gate. The offender/s have gained access by using unknown tool to exert force on the opening ram causing it to bend into a v shape and open the gate. Once inside, the offenders have taken a 10" x 5" challenger trailer which was left on the farmyard unsecured and full of wood. They have attached the trailer to a vehicle and towed it into a field adjoining the property. Once in the field they have unloaded the wood from the trailer and taken down an electric fence allowing them to drive access the road and leave (direction unknown). A neighbours CCTV has picked up the offending vehicles lights as it pulls onto the yard at offence time but is of no evidential value

This **BUSINESS THEFT** took place between **22:00:00** on **WEDNESDAY 31-AUG-2016** and **09:00:00** on **FRIDAY 02-SEP-2016** at **LINCOMB FISHERIES, LINCOMB LA, TITTON, STOURPORT ON SEVERN**

During the approximate times and dates stipulated POPU have used unknown means/instrument to damage a padlock which secured the main gate to the area where the IP owns a container for storage. The main gate is approximately a quarter of a mile from the container. POPU have then used unknown means/instrument to remove a padlock securing the container and a lawnmower and strimmer have been removed from the container. Egress unknown, however the IP found the padlock securing the main gate back on the gate closed

This **BURGLARY-OUTBUILDING** took place between **23:00:00** on **TUESDAY 06-SEP-2016** and **18:00:00** on **WEDNESDAY 07-SEP-2016** at **INN LA, HARTLEBURY, KIDDERMINSTER, WORCESTERSHIRE**

Between times/dates stated POPU have approached the rear garden of a terraced dwelling mews situated within a rural area of Hartlebury, Kidderminster. Offender/s have proceeded through an open arch which leads to a private insecure enclosed courtyard that leads on to 4 different dwelling rear gardens. POPU have accessed the victims rear garden via a small insecure wooden gate, there they have proceeded to remove and take items of property, including a chainsaw, from an open fronted wooden constructed shed, without the knowledge or consent of the victim. Offender/s egressed as entry making good their escape in an unknown direction by unknown means

This **CRIMINAL DAMAGE** took place between **18:00:00** on **FRIDAY 09-SEP-2016** and **07:00:00** on **MONDAY 12-SEP-2016** at **PEPWELL LA, CROSSWAY GREEN, STOURPORT ON SEVERN, WORCESTERSHIRE**

Between offence times on offence dates PUK have entered a field adjacent to the IP's property by cutting two padlocks as well as removing them. Once the field has been accessed via the gate a vehicle of some variety has driven across the field causing extensive damage to both the crop and the land

This **INTERFERENCE WITH MOTOR VEHICLE** took place between **21:30:00** on **MONDAY 12-SEP-2016** and **21:55:00** on **MONDAY 12-SEP-2016** at **TRAVELODGE, CROSSWAY GREEN, STOURPORT ON SEVERN, WORCESTERSHIRE**

IP parked his van on the carpark at the location. Other guests also working in the local area have disturbed POPUK trying to break into the sliding door on IP's van. These persons have made off in a black VW Golf, no further details. The suspects have cut into the sliding door making an L shape with implements unknown prior to be disturbed.

This **BURGLARY NOT DWELLING WITH INTENT TO STEAL** took place between **18:20:00** on **WEDNESDAY 14-SEP-2016** and **07:00:00** on **THURSDAY 15-SEP-2016** at **38, A P B TRADING, HARTLEBURY TRADING EST, HARTLEBURY, KIDDERMINSTER**

Suspects unknown have arrived at unit 38 on the Hartlebury Trading Estate in a Transit type van, parked out front of the main entrance of the yard which was secured by a metal chain link fence and barbed wiring. To the left of the main yard there is a smaller yard secured by the same chain linked fencing and padlocks. Suspects unknown have exited the Transit type vehicle and used wire cutters to cut the bottom right section of the chain link in the small yard. They have forced their way through the hole and once inside have cut the main padlock to the gate of the smaller yard. Suspects have then driven the Transit type vehicle into the small yard and rammed the metal shutters attached to the main building. Suspects have disabled the security light and on exiting the small yard in the transit vehicle have picked up a space frame buggy 4x4 and placed it into the back of the van. They have then left the smaller yard and made good their escape

Although unverified at this time, we do believe these people to have been involved in the spate of rural thefts that we have had across the area in recent months.
